### Northern Ireland Procurement Conference 2023

#### A new era for public procurement

Procurement is an important element of the Northern Ireland economy. Central and local government spends approximately £3 billion per year on procurement, of which £2.7 billion is spent by government departments and their arm's length bodies. Many private sector organisations also spend significant amounts in the local economy.

A new social value procurement policy came into effect last year in Northern Ireland. Since June 2022, social value must account for at least 10 per cent of the total award criteria for government tenders with the intention to increase to 20 per cent in June 2023, subject to Executive approval.

This new policy puts social value at the heart of public procurement, creating a benefit beyond the purchase of goods and services including delivering environmental benefits and job creation in deprived areas. It is focussed on four main areas:

- Increasing secure employment and skills
- Building ethical and resilient supply chains
- Delivering zero carbon
- Promoting Well-being

The Northern Ireland Procurement Conference 2023 will examine the progress to date and will look at any challenges and opportunities that have arisen since the implementation of this new policy.

This conference will have a genuine, in-depth understanding of the key issues via a high-level panel of local and visiting speakers and will examine both the challenges and opportunities in the future outlook for procurement in Northern Ireland.
